1 Introduction

On April 7, 2025, Levy Alameda LLC and Affiliates (Applicant) received a Second Determination of Incompleteness and Request for Information from the California Energy Commission (CEC) for the Potentia-Viridi Battery Energy Storage Project (Project; Docket Number 24-OPT-04) in response to the Applicant's previous submittals. This document responds to the CEC's request and provides further clarification on the Cultural and Tribal Cultural Resources related to the Project.

2 Cultural and Tribal Cultural Resources Response
