The California Energy Commission (CEC) will host a series of “How-To” workshops to provide guidance on how to complete application materials for the Round 2 Grant Funding Opportunity (GFO) for the Community Energy Reliability and Resilience Investment (CERRI) Program GFO-23-312r2. Each workshop will cover different topics related to the GFO application. These workshops will include a Question and Answer session for potential applicants.

The public can participate in the workshops consistent with the attendance instructions below. The log-in details for all three workshops are the same. The CEC aims to begin promptly at the start time posted, and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

 - **June 18, 2025:** How-To Workshop on Project/Applicant Eligibility, Project Narrative form, and Project Metrics form.

- **June 25, 2025:** How-To Workshop on Budget Forms, Site/Match Commitment Letters, and Vendor Quotes.
 - **July 2, 2025:** How-To Workshop on the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA) compliance forms.
4. **Application Support & Resources:** Share where potential applicants can access application support and resources.
 5. **Question and Answer Session:** Address questions from participants.

Background

The CERRI Program invests in deployment projects across California that increase community energy reliability and resilience, support California’s energy policies, improve energy justice and equity, and create good-paying jobs. Funding for this program was authorized under the federal Infrastructure Investment and Jobs Act Section 40101(d).

In recent years, California has experienced increased electrical system outages caused by climate-related events, such as increased wildfires, heat waves, and storms, or through public safety power shutoffs. These events and the state’s aging infrastructure threaten grid reliability, public health and safety, economic prosperity, communities, and ecosystems. They also pose disproportionate consequences for the most vulnerable populations in both rural and urban areas.

The intent of this program is to invest in deployment projects that increase electric grid reliability and improve the resiliency of communities in California by reducing outage frequency, duration, magnitude, and associated community impacts while bolstering California’s workforce and promoting equity.

The objectives of awarded projects must align with those of the CERRI Program. The CERRI Program aims to:

- **Reliability and Resilience:** Reduce the frequency, duration, and magnitude of power outages and strengthen communities’ ability to function during power outages.
- **Community Benefits:** Ensure that the benefits of clean, safe, affordable, and reliable energy are shared by all.
- **Advancement of Energy and Resilience Goals:** Support California’s energy modernization and resilience goals.
- **Workforce Development and Labor:** Create high-quality jobs with strong labor standards and protections that attract and train a skilled workforce for lasting careers in the growing clean energy industry.
