My name is Amanda Quintanilla and I have been a resident of Southern Orange County for over 50 years and I am a local activist for years. When looking at the California Energy Commission docket log, not all the public comments have been posted from the people who spoke at the May 29th meeting such as Assemblywoman Diane Dixon, Assemblywoman Laurie Davies, Max Werner rep for Senator Strickland, Former Mayor of San Clemente, Chris Hamm & President of Orange County Professional Firefighters, and others such as Laura Smith. I hope that this could be a transparent process and please include all of the public comments.

The public was informed that the California Energy Commission was going to be accepting public comments until 6 pm. Limiting the time and limiting public comments to only those who have not spoken before is a suppression of the free speech rights that are protected under the First Amendment.

I am in strong opposition to the Compass Energy Storage project in San Juan Capistrano. When listening to some of the public comments about placing a Battery Farm at San Onofre because they have energy lines, it is horrific.

San Onofre Nuclear Generating Station, SONGS, is a decommissioned nuclear power plant, but it still stores more

than 3.5 million pounds of nuclear waste in steel canisters surrounded by concrete. The plant was shut down in 2013 due to a small leak of radioactive steam, and its owner, Southern California Edison. They have been dismantling it in recent years.

The main cause of battery farm fires is thermal runaway, which is a chain reaction of overheating and self-ignition that can spread rapidly among battery cells. Thermal runaway can be triggered by various factors, such as internal cell defects, external short circuits, mechanical damage, overcharging, overheating or poor ventilation. Once thermal runaway starts, it can be very difficult to stop or contain. The high temperatures and pressures generated by the burning batteries can cause explosions and release flammable and toxic gases. Exposure to Hydrogen fluoride is lethal if inhaled and causes irreversible health effects after an hour of exposure.

Thermal Runaway can cause explosions at SONGS where they store more than 3.5 million pounds of nuclear waste and this would be like a Chernobyl, which was an explosion and it would be catastrophic.

In addition, please do not include the Prima Deshecha Landfill site since there are plans to expand this landfill in 2023 and that is currently under review. More importantly, the landfill site abuts the City of San Clemente Open Spaces and mitigated lands, which have conservation easements. Not to mention our open spaces are protected.

According to a SC Times article, <u>San Clemente, San Juan</u> <u>Capistrano Comment on Expansion of Nearby Landfill</u>, "The cities of San Clemente and San Juan Capistrano—both of which neighbor the Prima Deshecha Landfill—voiced their perspectives on the landfill's upcoming expansion late last week by submitting letters to Orange County Waste & Recycling (OCWR), the facility's owner and operator.

San Clemente expressed concerns related to impacts on air quality, hazardous materials, noise and more; San Juan Capistrano mentioned fire protection services, impacts to cultural resources significant to local Native American tribes, and traffic.

Both cities broached overlapping topics and requested to be included in the phases of the expansion to come.

"Given the project's proximity to (Forster Ranch and Talega) there is increased interest concerning the potential for these impacts to affect residents in these areas," wrote Dave Rebensdorf, San Clemente utilities director."

Locations for Compass Energy Storage facility in San Juan Capistrano or at San Onofre, and the Prima Deshecha landfill will have detrimental effects. Finding another location is not an option.

In addition to the heightened risk of wildfires, the proposed BESS project site presents significant environmental and public health risks. Lithium batteries emit toxic gases within seconds of igniting, leading to air pollution and public health risks. Any fire, regardless of

size generates a significant risk for our first responders' health should this project be approved.

Should first responders quickly extinguish a lithium battery fire, they would be exposed to hazardous toxic gases, which can cause severe debilitating health impacts. If the fire is not readily extinguished, the toxic gases emitted would generate a significant public health risk for the surrounding communities. Any water or fire extinguishing compounds used to combat the fire will become easily contaminated with heavy metals and absorbed into the region's soil, adversely impacting the local ecosystem and population. The project's close proximity to the Oso and Arroyo Creek waterbed further exacerbates potential water quality issues, contaminating the San Juan Creek Watershed, which flows to the Pacific Ocean just miles away.

I strongly urge the California Energy Commission to carefully and fully consider these adverse fire, economic, environmental, and public safety risks as they evaluate Compass Energy Storage's proposed project. The health and safety of California residents should always take precedence over any potential benefits proposed by this project. I respectfully request that the California Energy Commission reject this project application.

In this time, we have endured three fires, including one where fire trucks were stationed in front of and behind our house for over 24 hours due to a seemingly simple brush fire.

We are adamantly opposed to the installation of this battery storage facility in our neighborhood. The health and safety risks have been well-documented by others, and I won't reiterate those points. However, I must emphasize the significant danger this facility poses to our community and our employees.
