Pursuant to Section 25322 of the Public Resources Code ("PRC") and Section 2505(a)(4) of Title 20 of the California Code of Regulations ("CCR"), Shell Energy North America (US) L.P. ("SENA" or "Applicant") provides this Certification in support of its Application requesting that the Commission designate as confidential certain information contained in the attached IEPR Electricity Demand Forecast Forms. The information for which SENA seeks confidential treatment is substantially the same as the information for which the Commission granted SENA confidential treatment in Docket Nos. 19-IEPR-02 (June 5, 2019) and 22-IEPR-03 (December 2, 2022).

- 1. The information for which Applicant seeks confidential treatment is as follows:
 - A. Form 7.1 Energy Service Provider Report of Loads and Resources Under Contract

Applicant's Form 7.1 contains information about the actual and forecasted annual energy purchases for the years 2023-2036, annual and forecasted peak loads for the years 2023-2036 and customer counts for the years 2023-2036. See Lines 10-23 of Columns C, D, F (PG&E Retail Sales, Peak Demand, Nonresidential Customer Counts), H, I, K (SCE Retail Sales, Peak Demand, Nonresidential Customer Counts), M, N, P (SDG&E Retail Sales, Peak Demand, Nonresidential Customer Counts).

2. Length of time for which information should be maintained on a confidential basis.

SENA requests that the historical information for 2023-2024 in Form 7.1 that is designated as confidential be maintained on a confidential basis for a period no less than one (1) year (through December 31, 2026), and that forecast information for 2025-2036 that is designated as confidential be maintained on a confidential basis for a period no less than three (3) years (through December 31, 2028).

3. Aggregation of Data

The confidential information submitted by Applicant may be released to the public if first aggregated with all other electric service provider demand forecasts.

4. Penalty of Perjury Certification

I certify, under penalty of perjury, that this information is substantially similar to information previously submitted in Docket Nos. 19-IEPR-02 and 22-IEPR-03 for which confidential treatment was granted (except that confidential treatment is requested for information for the years 2023 through 2036), and that all the facts and circumstances relevant to confidentiality remain unchanged, in accordance with CCR Title 20, Section 2505(a)(4).
