As part of the 2025 Integrated Energy Policy Report- Electricity and Gas Demand Forecast process, the California Energy Commission (CEC) sought from California Department of Water Resources (CDWR) Publicly Owned Utility (POU) form information. Portions of the information on the POU information template are confidential. Previously, in 2023 under 2023 IEPR Demand Forecast process, CDWR submitted substantially similar data to the California Energy Commission with an application for confidential designation, which was granted by the Executive Director pursuant to California Code of Regulations, title 20, section 2505(a)(4). (See July 26, 2023, CEC letter from D. Bohan to CDWR granting confidential designation for daily gas demand data, Docket No. 23-IEPR-02.)

Certification of Confidentiality by Jorge L. Quintero Pursuant to Title 20, §2505(a)(4) (Repeated Applications for Confidential Designation)

I, Jorge Luis Quintero, do certify as follows:

1. I am an Assistant Division Manager under the Division of Operations and Maintenance within State Water Project, Department of Water resources overseeing the Power Operations Management. I have reviewed the confidential information provided in the template that is applicable to CDWR. I am also familiar with the contents of the previous filing for the demand forecast which was granted confidential designation on July 26, 2023.
2. The demand forecast data being provided here is substantially similar to the demand forecast data that was previously granted confidential treatment on July 26, 2023.
