The California Energy Commission (CEC) will host a remote-access workshop addressing barriers and solutions to accelerating clean energy interconnection and energization, as directed by Assembly Bill 1373 (Garcia, Chapter 367, Statutes of 2023). This workshop will build on the work of the *2023 Integrated Energy Policy Report (IEPR)* on interconnection and energization and provide an update on new developments related to these issues.

This workshop is part of the 2025 IEPR proceeding. Chair David Hochschild is the CEC's lead commissioner for the *2025 IEPR*, with Vice Chair Siva Gunda as associate commissioner. The CEC aims to begin promptly at the start time posted, and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

Agenda

This workshop will include presentations and discussion on the status of improvements to interconnection and energization processes, including trends and progress in connecting clean energy resources and customer loads. The workshop will also gather suggestions on the policies or process improvements that could enhance and address any ongoing interconnection and energization issues.

Background

To meet its reliability and clean energy goals, California needs to accelerate the pace of clean energy resource deployment, including flexible loads connected at the distribution level as well as grid-scale renewables and storage connected at the transmission level. The *2023 IEPR* examined the barriers to closing the clean energy resource deployment gaps and provided recommendations to accelerate deployment. Since 2023, there have been ongoing efforts to enhance grid interconnection and energization. Assembly Bill 1373, under Public Resources Code Section 25302.6, directs the CEC, in consultation with the California Public Utilities Commission (CPUC), to assess barriers to interconnection and energization and provide recommendations on solutions to these barriers as part of the *2025 IEPR*. This workshop will build on the *2023 IEPR* and provide updates on related developments.
