**PLEASE TAKE NOTICE** that the California Energy Commission (CEC) Committee<sup>1</sup> assigned to conduct proceedings on the Application for Certification (AFC, or application) for the Willow Rock Energy Storage Center (Willow Rock, or proposed project) has scheduled a public Prehearing Conference and a public Evidentiary Hearing as follows:

The Committee aims to begin both events promptly at the start times posted, and the end time for each event is an estimate based on the proposed agenda. The Prehearing Conference and Evidentiary Hearing may end sooner or later than the posted end times. The Committee will determine whether the Evidentiary Hearing will continue on the second day either during the Prehearing Conference on August 15, 2025, or during the first day of the Evidentiary Hearing on August 21, 2025, to accommodate the time necessary for the Parties to introduce their evidence and question the expert witnesses. If the Evidentiary Hearing adjourns on August 21, 2025, it will not convene or continue on August 22, 2025 and the presiding member will post a notice of adjournment.

**Prehearing Conference**

All Parties will join the Prehearing Conference remotely via Zoom. The public may attend the Prehearing Conference and provide comment remotely via Zoom as well.

**Evidentiary Hearing**

The Committee urges all Parties and their representatives and expert witnesses to appear at the Evidentiary Hearing in person to help ensure all participants have the opportunity to hear the entire proceeding while it is taking place and to observe the exhibits without concern of an internet disconnection stopping the hearing. The public may attend the proceedings and provide comment in person or remotely, consistent with the attendance instructions below.

**BACKGROUND**

On December 1, 2021, GEM A-CAES LLC (Applicant) filed an AFC with the CEC to construct and operate the Gem Energy Storage Center.<sup>2</sup> On August 5, 2022, Applicant changed the name of the project to the Willow Rock Energy Storage Center.<sup>3</sup> On March 8, 2024, Applicant filed a Supplemental AFC (Supplemental AFC) which relocated and reconfigured the proposed project. The Supplemental AFC proposes a nominal 520 MW gross (500 MW net) and 4,160 MWh gross (4,000 MWh net) compressed air energy storage facility deploying Hydrostor Inc. (Hydrostor) Advanced Compressed Air Energy Storage (A-CAES) technology and related accessories. The proposed project would be sited north of Dawn Road and between State Route (SR) 14 and Sierra Highway within unincorporated Kern County, California, approximately 4 miles north of Rosamond, California. Energy stored at Willow Rock would be delivered to Southern California Edison's (SCE's) Whirlwind Substation located southwest of

the site at the intersection of 170th Street W and Rosamond Boulevard, via a new approximately 19-mile 230-kilovolt (kV) generation-tie (gen-tie) line.

The Applicant filed the AFC under the CEC's licensing process. If approved, construction is proposed to begin by December 2025 with commercial operation to begin by November 2030.

The Parties to this proceeding include the Applicant, CEC Staff, and Intervenors California Unions for Reliable Energy (CURE)<sup>4</sup> and the Center for Biological Diversity (the Center).<sup>5</sup>

### **PURPOSE OF PREHEARING CONFERENCE**

The first event under this notice is the Prehearing Conference on August 15, 2025. The Prehearing Conference is a public forum in which the Committee will assess the Parties' readiness for the Evidentiary Hearing, discuss the format and agenda of the Evidentiary Hearing, identify areas of agreement or dispute, and discuss the remaining schedule and procedures necessary to conclude the application process.<sup>6</sup>

### **PURPOSE OF THE EVIDENTIARY HEARING**

The second event under this notice is an Evidentiary Hearing beginning on August 21, 2025 and continuing to August 22, 2025 as necessary. The Evidentiary Hearing is an administrative adjudicatory proceeding to receive evidence into the formal hearing record from the parties. Only the Parties may present evidence for introduction into the formal hearing record, which is the only evidence upon which the CEC may base its decision under the law. Testimony offered by the Parties shall be under oath. Each Party has the right to present witnesses, introduce exhibits, and to rebut the evidence of another Party. At an Evidentiary Hearing for an AFC, the Committee shall consider the topics enumerated in California Code of Regulations, title 20, section 1745.5 to support the subsequent preparation of the proposed decision on the Application.<sup>7</sup>

### **PROCEDURES FOR THE EVIDENTIARY HEARING**

Pursuant to California Government Code section 11445.10 et seq., and the California Code of Regulations, title 20, section 1210, the Committee elects to conduct all or portions of the Evidentiary Hearing using an informal procedure.

The informal hearing process will generally proceed in the following order:

1. At the Prehearing Conference, the Committee will confirm the subject areas for which any Party plans to offer an expert witness for oral testimony. "Subject areas" shall align with those identified in the table of contents of the Final Staff Assessment.<sup>8</sup>
2. For any subject area identified at the Prehearing Conference for oral testimony, all Parties' expert witnesses on that subject area will be sworn in together and testify as a panel. The Committee will convene separate panels for each individual subject area identified for oral testimony.
3. Applicant's expert witnesses will provide a brief opening statement summarizing the key points and conclusions of their testimony.
4. CEC Staff's expert witnesses will provide a brief opening statement summarizing the key points and conclusions of their testimony.
5. Intervenor's expert witnesses will provide a brief opening statement summarizing the key points and conclusions of their testimony.
6. The Committee will facilitate discussion among the expert witnesses on each panel.
7. The Committee may allow Parties to follow up with questions of any expert witness to the extent the Committee finds the questioning productive.
8. At the conclusion of the Parties' examination of the expert witnesses, the Committee may ask the expert witnesses additional questions. If productive, the Committee may facilitate questions and answers between the expert witnesses.
9. If the Evidentiary Hearing adjourns on August 21, 2025, the presiding member will post a notice on the evening of August 21, 2025 cancelling further proceedings on August 22, 2025.

## **ORDERS REGARDING EVIDENCE, WRITTEN TESTIMONY, EXHIBIT LISTS, AND PREHEARING CONFERENCE STATEMENTS**

All Parties intending to submit evidence for consideration at the Evidentiary Hearing are **ORDERED** to docket evidence, written testimony, exhibit lists, and prehearing conference statements no later than 5:00 p.m. on the dates specified in the above schedule, and in accordance with the following directions. Failure by a Party to comply with the filing requirements stated in this Order may preclude that party from participating in the Evidentiary Hearing.

### **Evidence and Written Testimony**

All evidence and written testimony must be docketed in this proceeding's docket (21-AFC-02) and have a transaction number (TN) assigned by the CEC's Dockets Unit. Exhibits without a TN, or not docketed in this proceeding's docket, will not be received into evidence absent a showing of good cause. If the document is already docketed, it need not be refiled; simply provide the TN on the Exhibit List. **IMPORTANT: Each exhibit must have a unique TN and Exhibit number. Do not group several TNs under a single exhibit number or group several exhibits under a single TN.**

## Exhibit Lists

Hearing Office staff will then add the exhibit number information to the e-filing system. ## Prehearing Conference Statements

Pursuant to the schedule above, each Party shall file a Prehearing Conference Statement. The Prehearing Conference Statement must specify under separate headings:

1. The subject areas<sup>10</sup> that are complete and ready to proceed to Evidentiary Hearing.
2. The subject areas upon which the Party proposes to introduce testimony in writing rather than through oral testimony.
3. The subject areas that are not complete and not yet ready to proceed to Evidentiary Hearing and the reasons therefor.
4. The subject areas that remain disputed and require adjudication, and the precise nature of the dispute for each issue.
5. The identity of each expert witness the Party intends to sponsor at the Evidentiary Hearing, the subject area(s) about which the expert witness(es) will offer testimony, whether the testimony will be oral or in writing, a brief summary of the testimony to be

offered by the expert witness(es), qualifications of each expert witness, the time required to present testimony by each expert witness, and whether the expert witness seeks to testify via Zoom.

6. Any objections that the Party may have to oral testimony provided by videoconference, including solutions for the Committee to be able to structure the hearing in a manner that can address the objections.
7. Subject areas upon which the Party desires to question the other Parties' expert witness(es), a summary of the scope of the questions (including questions regarding expert witness qualifications), the issue(s) to which the questions pertain, and the time desired to question each expert witness. **NOTE:** A Party who fails to provide, with specificity, the scope, relevance, and time for questioning other Parties' expert witness(es) risks preclusion from questioning on that subject area.
8. A list identifying exhibits with transaction numbers (TN) that the Party intends to offer into evidence during the Evidentiary Hearing and the technical subject areas to which they apply (see above for further details on Exhibit Lists).
9. Proposals for post-hearing briefing deadlines, resolving scheduling conflicts, or other scheduling matters.

## **TRANSCRIPTS**

The Prehearing Conference and Evidentiary Hearing will be officially transcribed by a court reporter and filed to the docket. Parties are responsible for identifying errors in the transcripts of the proceedings. Corrections to the transcripts must be docketed within 30 days of the filing of a transcript.

## **GOVERNMENT AND PUBLIC PARTICIPATION**

Government entities including California Native American tribes and local, state, and federal agencies, interested persons, and members of the public may attend the proceedings via Zoom or in person, as instructed above, and may provide oral comments during designated times during the proceedings. Additionally, representatives of tribal governments and local, state, and federal agencies may participate in the Evidentiary Hearing as expert witnesses to provide testimony.

### **Public Comment**

Written and oral comments, attachments, and associated contact information (including address, phone number, and email address) will become part of the public record of this proceeding with access available via any internet search engine.
