The California Energy Commission (CEC) has received Commercial Energy of Montana, Inc. dba Commercial Energy of California (applicant) repeated application (TN 263614) for confidential designation, docketed June 1, 2025, for the following:

2024 Power Source Disclosure Annual Report

The applicant states that these records were previously determined by the CEC's executive director to be confidential (TN 258727). The applicant requests the data be confidential until December 31, 2025. This term is consistent with the one-year period this type of data is considered confidential by the CPUC. (See Order Instituting Rulemaking, R.05-06-040, D.06-06-066 Appendix 2 and D.08-04-023 Appendix B, ESP Confidentiality Matrix Section V Market Purchases of Energy and Capacity.) The applicant asserts, under penalty of perjury, that the 2024 Power Source Disclosure Annual Report contain information that is substantially similar to previously submitted information that was granted confidential designation, and all facts and circumstances relevant to the confidentiality of the information remain unchanged.

California Code of Regulations title 20, section 2505(a)(4) provides:
