The California Energy Commission (CEC) has received Southern California Gas Company's (applicant) repeated application for confidential designation, docketed July 17, 2025 (TN 264855), for the following:

The applicant states that these records were previously determined by the CEC's executive director to be confidential indefinitely (Docket No. 23-IEPR-03, TN 250889). The applicant asserts, under penalty of perjury, that Form 1.4 (highlighted portion) of applicant's 2025 Electricity Demand Forecast contains information substantially similar to previously submitted information that was granted confidential designation, and all facts and circumstances relevant to the confidentiality of the information remain unchanged.
