Dear Director Gary Ray,

On behalf of the Committee assigned by the California Energy Commission (CEC) to manage the application for certification for the Willow Rock Energy Storage Center project, I respectfully request a representative from the Eastern Kern Air Pollution Control District to appear at the Evidentiary Hearing on August 21 & 22, 2025. The request is to fulfill the statutory and regulatory requirements for such appearance to testify and certify to the emissions offsets for the proposed Willow Rock Energy Storage Center pursuant to Public Resources Code, section 25523(d)(2), and to present and explain the determination of compliance for District rules and regulations pursuant to Cal. Code Regs, title 20, section 1744.5(c).

Public Resources Code, section 25523(d)(2) provides:

“The commission may not find that the proposed facility conforms with applicable air quality standards pursuant to paragraph (1) unless the

applicable air pollution control district or air quality management district certifies, prior to the licensing of the project by the

commission, that complete emissions offsets for the proposed facility have been identified and will be obtained by the applicant within the

time required by the district's rules or unless the applicable air pollution control district or air quality management district certifies

that the applicant requires emissions offsets to be obtained prior to the commencement of operation consistent with Section 42314.3 of

the Health and Safety Code and prior to commencement of the operation of the proposed facility.”

And the CEC’s Regulations at Cal. Code Regs., title 20, section 1744.5(c) provides: “The local district or the Air Resources Board shall provide a witness at the hearings held pursuant to Section 1745 to present and explain the [District’s] determination of compliance.”
