# **Background**

Public Resources Code sections 25545 - 25545.13 allows specified clean energy projects to seek consolidated permitting at the CEC until June 30, 2029. These projects include solar photovoltaic (PV) electrical generating power plants generating 50 megawatts (MW) or more, energy storage systems capable of storing 200 megawatt-hours (MWh) or more, electric transmission lines associated with these generating and storage facilities to the first point of interconnection, specified facilities that manufacture or assemble clean energy or storage technologies or related components, and certain hydrogen production facilities not derived from fossil fuel feedstock and associated onsite storage and processing.

Under this program, the CEC permit is in lieu of any permit that would normally be required by the local land use authority and most, but not all, state permits. The law also requires the CEC to be the lead agency under the California Environmental Quality Act (CEQA) and, after an application is deemed complete, to do the following:

- 1. Prepare a Staff Assessment, which includes an environmental impact report (EIR).
- 2. Hold public meetings as close as practicable to the proposed project site.

- 3. Invite consultation with California Native American tribes that are culturally and traditionally associated with the geographic area of the proposed site.
- 4. Certify compliance with requirements for community benefits, labor standards, and economic benefits.
- 5. Approve or deny the proposed project at a publicly noticed business meeting.

Soda Mountain Solar, LLC (applicant) filed an Opt-In application on August 1, 2024, for the Soda Mountain Solar Project proposed in unincorporated San Bernardino County, California. On September 3, 2024, and June 18, 2025, the CEC deemed the application incomplete and docketed letters detailing the information deficiencies. On July 31, 2025, after receiving additional data, the CEC determined that the application was complete and on July 31, 2025, the CEC sent applicable California Native American tribes a letter inviting tribal consultation on the Soda Mountain Solar Project. The CEC sent a Notice of Preparation of a Draft EIR (NOP) to analyze the potential environmental impacts of the project to the State Clearinghouse (Land Use and Climate Innovation, LCI), and mailed the NOP on August 1, 2025 to trustee agency, San Bernardino County Clerk, local, regional, and federal agencies, including those who commented on the California Department of Fish and Wildlife NOP from previous environmental document. # **Project Summary**

The applicant proposes to construct, operate, and maintain a utility-scale solar PV electrical generating and storage facility and associated infrastructure (operations and maintenance buildings, stormwater infrastructure, and related infrastructure improvements) to generate and deliver renewable electricity to the statewide electricity transmission grid. The proposed project would generate up to 300 MW of renewable energy and include up to 300 MW/1,200 MWh of battery storage. The batteries would be lithium ion or similar. The project would include a switchyard and substation.

The power produced by the proposed project would be conveyed to the regional electrical grid through an interconnection with the existing Mead-Adelanto 500-kilovolt (kV) transmission line operated by the Los Angeles Department of Water and Power (LADWP). The approximately 200 foot wide, 1-mile long 500 kV gen-tie line would run from the project substation, just southeast of Interstate-15 (I-15), to the switchyard and then to the point of interconnection with the existing LADWP Mead-Adelanto transmission line. A small segment of the gen-tie line, approximately 450 feet, would cross I-15.

## **Purpose of the Informational and Environmental Scoping Meeting**

The Informational and Environmental Scoping Meeting will provide an opportunity for interested members of the public, including surrounding communities, to learn about the proposed project and the CEC's Opt-In Certification process. The public will be able to obtain information, identify areas of environmental concern to be addressed during the CEC's environmental review of the project, and provide comments.

During the public meeting, the applicant will explain its proposed plans for constructing and operating the project and related facilities. CEC staff will describe the CEC and staff's role and responsibilities in reviewing the Opt-In application and engaging with government agencies, the public, and California Native American Tribes to inform this review. The CEC's Public Advisor will describe how interested members of the public can participate in the process, including during the environmental review and CEC decision-making.

The CEC will prepare a Staff Assessment (SA). The SA will include a Draft EIR following the requirements of the California Environmental Quality Act (Pub. Resources Code, § 21000 et seq.) and the CEQA Guidelines (Cal. Code Regs., tit. 14, div. 6, ch. 3). The Notice of Preparation of the Draft EIR is available at:

The CEC is conducting public outreach to solicit input on the Soda Mountain Solar Project application to identify the range of actions, alternatives, mitigation measures, and significant effects to be analyzed in depth in the Draft EIR. This meeting also assists CEC staff in obtaining additional information to prepare the Draft EIR and determining whether the project meets all program requirements.
