  - (a) RSES is only one of three ATTCPs producing this type of certification/training for the state of California.
  - (b) If not kept confidential, other ATTCPs might know how we structure our training and use/modify it to create their own and be in direct competition with RSES.
  - (c) At present, the information has no monetary value, however, based on past trainings, we estimate materials to value at around or above \$40,000.00.
  - (d) As of the date of this application, there is no chance of acquisition or duplication as it has not been made public. Once it goes public after Dec. 31, 2025, confidentiality is no longer an issue.
6. Data can be disclosed if 75% of the questions/answers are masked.
7. As of the date of this letter, this material has not been disclosed to anyone outside of RSES.
