The California Energy Commission (CEC) will host a workshop to discuss the informational proceeding concerning mid-transition petroleum supply stabilization, including evaluation of the refiner minimum inventory and resupply planning provisions of Assembly Bill (AB) X2-1 (Stats. 2024, 2nd Ex. Sess. 2023-2024, Ch. 1). AB X2-1 requires the CEC to consider the effects of refiners' inventories of fuel and feedstocks and blending components on the price of transportation fuels in California. AB X2-1 also authorizes the CEC to consider ways to minimize the impact of maintenance-related production losses on fuel prices, while protecting the health and safety of employees, local communities, and the public.

The public can participate in the workshop consistent with the attendance instructions below. The CEC aims to begin promptly at the start time posted, and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

### **Agenda**

This workshop will present staff's evaluation of strategies to maintain reliable fuel supplies as California transitions away from petroleum. The focus will be on minimum inventory requirements, refinery resupply planning, and other stabilization tools. It provides a transparent forum for stakeholder input and data sharing. The proceeding aims to protect consumers from price spikes, strengthen supply reliability, and build a comprehensive public record to guide decisions. The workshop will include a public comment period.

## Background

Assembly Bill (AB) X2-1, which took effect on January 13, 2025, requires the CEC to consider the effects of refiners' inventory on the price of transportation fuels in California. The bill authorizes the CEC to develop requirements for refiners operating in the state to maintain minimum levels of inventories and to plan for resupply of lost production during planned maintenance or turnarounds. AB X2-1 builds on Senate Bill (SB) X1-2, which aims to improve transparency into the petroleum industry and prevent consumer price spikes.

CEC is hosting this Petroleum Supply Stabilization workshop to explore strategies for maintaining a safe, reliable fuel supply as California transitions away from petroleum. Authorized under AB X2-1, the proceeding will evaluate tools such as minimum inventory requirements and refinery resupply planning, while remaining open to other stabilization measures. The goal is to create a transparent forum where interested members of the public can share input and data, build a clear public record, and assess potential benefits, costs, and risks before any regulatory action is considered. With refining capacity declining faster than demand, the state faces heightened risks of price spikes and supply disruptions. This workshop is a proactive step to protect consumers, support economic stability, and ensure decisions are grounded in evidence and broad engagement from interested members of the public.
