## **Notice of Public Comment Period**

### **California Home Energy Efficiency Rating Services (CHEERS) Energy Code Compliance Provider Application and Data Registry Application**

#### **Background**

The Energy Code Compliance (ECC) Program supports building energy projects in demonstrating compliance with the Energy Code through required testing and documentation. It helps ensure both code compliance and the quality installation of efficiency measures that consumers expect. The ECC Program is administered by ECC-Providers that train and certify ECC-Raters to determine whether installed energy efficiency measures meet Energy Code requirements. ECC-Providers must be approved by the California Energy Commission (CEC) to administer the ECC Program and to provide a residential data registry.

#### **Availability**

California Home Energy Efficiency Rating Services (CHEERS) has submitted an ECC-Provider Application and a 2025 Energy Code Residential Data Registry Application. Both applications can be accessed on the CEC's [website](http://www.energy.ca.gov), available at [efiling.energy.ca.gov/Lists/DocketLog.aspx?docketnumber=25-bstd-01](http://efiling.energy.ca.gov/Lists/DocketLog.aspx?docketnumber=25-bstd-01) (see table below for the docket TN identification numbers for each application document).

These applications are comprised of multiple filings submitted by "CHEERS Inc". Interested members of the public may review the publicly filed documents and are welcome to submit comments. Please see the section "Public Comment" for details.

Comments submitted before October 6, 2025, will be considered in the executive director's recommendation to the CEC to approve, limit, or reject the CHEERS applications. The CEC will consider this recommendation at the next-possible, regularly scheduled business meeting.

CEC staff has evaluated the public and confidential filings and has found the applications to be complete with regard to the application processes of the California Code of Regulations, title 20, section 1674(c)(3), and title 24, part 1, article 1, section 10-110(a). Table 1 lists the applicable filings. The applicant may revise any document to address necessary changes to its application.
