The California Energy Commission (CEC) will present and gather feedback on the Draft *Renewables Portfolio Standard Eligibility Guidebook (RPS Guidebook), Tenth Edition*. The Draft *RPS Guidebook, Tenth Edition*, is available on the [CEC website](http://energy.ca.gov), and a staff workshop will be held on October 2, 2025.

The public can participate in the meeting by following the attendance instructions below. The CEC aims to begin promptly at the start time posted, and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

A quorum of commissioners may participate remotely, but no votes will be taken.

CEC staff will present the proposed revisions for the *RPS Guidebook, Tenth Edition*, followed by a public comment period. ## Background

The *RPS Guidebook*, in its Ninth Edition, describes the eligibility requirements and process for certifying facilities as RPS-eligible and the rules and process for verifying renewable energy certificates (RECs) for compliance with California's RPS program. The *RPS Guidebook* is revised periodically to reflect statutory, market, and regulatory developments, as appropriate.

The goal of this workshop is to present draft revisions to the *RPS Guidebook*, enhance understanding of the proposed revisions, answer clarifying questions from the public on the proposed revisions, and provide interested parties an opportunity to comment on the draft *RPS Guidebook, Tenth Edition*.

Staff will consider public comments on this workshop and the draft *RPS Guidebook* to inform the final *RPS Guidebook* draft for consideration by the CEC at a regularly scheduled business meeting. [Public Resources Code Section 25747](#) authorizes the CEC to approve substantive changes to the *RPS Guidebook* upon providing ten days of public notice. Changes take effect once approved by the CEC at a publicly noticed meeting.

If and when adopted, the draft RPS Guidebook, Tenth Edition will replace the *RPS Guidebook, Ninth Edition Revised*, which is currently in effect and available at <https://www.energy.ca.gov/programs-and-topics/programs/renewables-portfolio-standard>.


