The California Energy Commission (CEC) has received your California Public Records Act (PRA) request below on September 3, 2025.

Request:

"Perhaps you have overlooked that the attached email from the public advisor contradicts your statements:

"A date range for the 'alldata' and 'realtime' queries is not needed. Date ranges are only needed for historical value queries. This is all explained in the GitHub documentation with examples."

GitHub documentation does not support this procedural innovation:

"If the 'realtime' query is returning null, it's probably for an outdated Rate Identification Number.".

Did you know when querying for a outdated Rate Identification Number or invalid Rate Identification Number, MIDAS returns as follows:

What are the sources of your statements and the statements of the public advisor in the attached email?"

In accordance with Government Code section 7922.535, the CEC has determined your request, in whole or in part, seeks copies of disclosable public records in its possession. Please see the attached records.

Some of the records identified in response to your request are not disclosable public records and have been withheld as allowed under California law as follows: Evidence Code section 954 (attorney client privilege) and California Code of Civil Procedure section 2018.030 (attorney work product).

In response to your question, the information provided from the Office of the Public Advisor was based upon an unclear query to staff. The information I provided in my previous email, dated September 2, 2025, was correct.

Thank you, Mona! We'd appreciate it if you could send Mr. Uhler the response. Here is the explanation -

"

We looked into your query, and after testing it with the specified RIN, we were able to retrieve results successfully when using the "alldata" query type.

However, for the "realtime" query type, the system requires a date range to be specified in the request. When no date range is provided - as was the case in your request - the query will return empty fields, which is expected behavior.

We ran the same query without a date range and encountered the same result (i.e., no data returned). Once a proper date range is included, the system should respond with the expected data.
