For your information, I will be submitting the attached agreement in Jaggaer between Compass Energy Storage, LLC and the Saddleback College Foundation.

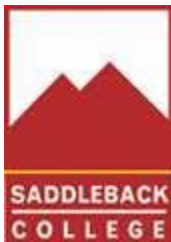
