## Background

- Warren Alquist Act, Public Resources Code (PRC 25402), mandates reduction of "wasteful, uneconomic, inefficient, or unnecessary consumption of energy"
  - Signed into law in 1974
  - Requires:
    - Periodic updates of the Building Efficiency Standards
    - Building departments to enforce the standards through the permit process
  - Allows local jurisdictions to enforce more stringent cost-effective standards
  - Scope typically includes newly constructed buildings, additions & alterations to existing buildings; residential and nonresidential

## State Energy Resources Conservation and Development Act

Public Resources Code Section 25000 et seq.



## **AB130 approved June 30, 2025**

- Prohibits updates of building standards affecting residential units, with a few exceptions, unless they take effect on or after January 1, 2032
  - No 2028 Energy Code update for residential units
  - Residential units include nontransient and transient units e.g. hotel / motel
  - Local code updates have to be:
    - Filed by the governing body of the city or county as of September 30, 2025, and/or
    - Necessary to align with a general plan approved on or before June 10, 2025 that permits mixed-fuel residential construction consistent with federal law while also incentivizing all-electric construction as part of an adopted greenhouse gas emissions reduction strategy



# 2028 Energy Code updates will focus on nonresidential buildings

#### **State Goals**

- Contribute to the state's GHG reduction goals
- Increase building energy efficiency cost-effectively

## 2028 Energy Code Strategies - Nonresidential Buildings and Covered Processes

- Covered process
  - Data centers, controlled environment horticulture, process steam and boilers, compressed air
- Building envelope
- New and replacement HVAC and water heating systems
- Lighting power density and controls
- Elevators
