## Lithium ion plant in our community

Dear Members of the Vacaville Planning Division,

I am writing as a concerned neighbor of the proposed lithium-ion battery manufacturing plant slated to be built directly behind our residential community in Vacaville. While I understand the importance of advancing clean energy and battery technologies, placing such a facility so close to homes raises serious public health and safety concerns that I respectfully ask you to reconsiderâ€"and to instead require locating the plant in a more appropriate, non-residential zone.

Large-scale lithium-ion battery plants carry distinct risks. When lithium-ion cells are damaged, stressed or overheated, they may undergo thermal runawayâ€"a chain reaction of heating, fire and gas releaseâ€"posing explosion and fire hazards. Fires in these systems are extremely hard to extinguish, can emit toxic gases and are a risk to first-responders and the public. In the event of an uncontrolled incident, adjacent homes could face evacuation, toxic smoke exposure, and long-term contamination of soil or air.

Moreover, battery manufacturing involves materialsâ€"such as cobalt, nickel and lithium compoundsâ€"that have been associated with respiratory issues, neurological effects and environmental contamination in exposed communities. "¿¼ The cumulative impact on a neighborhood of families, children, elders and people with respiratory vulnerabilities (such as asthma) is unacceptable.

For the safety and wellbeing of our community, I urge the City of Vacaville to require that this facility be sited away from residential neighborhoods, in an appropriately zoned industrial or buffer-zone location that minimizes risk to the public, and after full environmental and safety impact review. Locating the plant away from homes will better protect our families, property values, and emergency-response readiness.

Thank you for your serious consideration of this request. I trust that you share a commitment to safe, responsible development that protects our community's health, welfare and quality of life.
