The California Energy Commission (CEC) will host a workshop to gather feedback from interested parties on a future hydrogen refueling infrastructure solicitation. During the workshop, CEC staff will present a solicitation concept that will support the deployment of hydrogen refueling infrastructure in California.

Background

Assembly Bill (AB) 118 (Nuñez, Chapter 750, Statutes of 2007), created the Clean Transportation Program. The statute authorizes the CEC to develop and deploy alternative and renewable fuels and advanced transportation technologies to help attain the state's climate change and clean air goals. AB 126 (Reyes, Chapter 319, Statutes of 2023) reauthorized funding for the program through July 1, 2035 and focused the program on zero-emission transportation. AB 126 also directs the CEC to allocate at least 15 percent of Clean Transportation Program funds per year for hydrogen refueling infrastructure.

This pre-solicitation workshop aims to gather feedback on a proposed solicitation concept that will result in projects that increase the hydrogen refueling infrastructure needed to support the deployment of fuel cell electric vehicles in California.
