In conjunction with the filing of its Electricity Resource Plan Supply forms, CleanPowerSF hereby submits a Repeated Application for Confidential Designation for its Electricity Resource Plan Supply Forms (Supply Forms) pursuant to Cal. Code Reg. section 2505(a)(4). CleanPowerSF is the community choice aggregator (CCA) for the City and County of San Francisco, which is operated by the San Francisco Public Utilities Commission.

The Energy Commission previously designated as confidential the information provided in CleanPowerSF's 2025 Supply Forms pursuant to Cal. Code Reg. section 2505(b). CleanPowerSF requests the same confidentiality designation for the information provided in this year's Supply Forms, because the information is substantially similar to the information previously submitted in its 2025 Supply Forms. All facts and circumstances relevant to confidentiality remain unchanged from those in CleanPowerSF's 2025 Application for Confidentiality. As explained in its 2025 Application, CleanPowerSF relies on Government Code sections 7927.705 (formerly 6254(k)) and 7922.000 (formerly 6255(a)) and Evidence Code section 1060 as the basis for confidentiality of the information identified in this Repeated Application.

The data for which CleanPowerSF seeks confidential designation in S-1, S-2,S-2A, and S-5 is clearly highlighted in yellow, and the confidential file is conspicuously labeled as "Confidential."

Similar to CleanPowerSF's 2025 supply forms, the information provided in this year's supply forms falls into two broad categories: 1) information related to CleanPowerSF's Resource Adequacy (RA) obligation, forecasts, and projected compliance; and 2) CleanPowerSF's energy demand forecasts and projected Renewables Portfolio Standard (RPS) compliance. The following specific data apply to either or both above categories for which CleanPowerSF requests confidential designation.

a. Form S-1, Capacity/Energy Requirement

The confidential information in Form S-1 includes the "Peak Load Calculations" and related inputs. Specifically, Lines 1, 5-8, and 11, Columns I-R. It also includes the "Energy Demand Calculations" and related inputs. Specifically, Lines 12, 16, and 18, Columns I-L.

The confidential information in Form S-5 includes recently acquired resources for RA obligations and system energy as indicated in Lines 6b, 6c, 6d, 6s, 6u, 6v, 7b, 7e, 7f, 7g, 7h, 7k, 7n, 7o, 7ac, 7ad, 7ae, 7af, 7ao, 7ap, 7aq, 7ar, 7as, 7at, 7au, 7av, 7aw, 7ax, 7ay, 7az, 7ba, 7bb, 7bf, and 7bg.

II. Time Period for Confidential Treatment

CleanPowerSF requests confidential treatment for the following time periods that parallel the amount of time that CleanPowerSF protects its forecasts in California Public Utilities Commission (CPUC) supply data submissions:

- RA data in Form S-2: 2024, plus ten (10) year forecast period (2024 to 2034).
- RPS data: Current year and a two (2) year forecast period (2025 to 2027); and
- RA capacity forecasts in Form S-2A: 2024, plus ten (10) year forecast period (2024 to 2034).

The Energy Commission previously granted the same lengths of time for confidential treatment related to substantially similar information provided in CleanPowerSF's 2025 Supply forms.ⁱⁱⁱ

III. Certification

I certify that the information submitted in CleanPowerSF's 2026 Electricity Resource Plan supply forms is substantially similar to the previously submitted information in CleanPowerSF's 2025 Electricity Resource Plan supply forms and that all the facts and circumstances relevant to confidentiality remain unchanged.

I certify under penalty of perjury that the information contained in this application for confidential designation is true, correct, and completed to the best of my knowledge. I also certify that I am authorized to make the application and certification on behalf of CleanPowerSF.
