

RE: San Francisco Public Utilities Commission's Repeated Application for Confidential Designation for Electricity Resource Plan Form T-1 issued by the California Energy Commission in support of the 2026 Integrated Energy Policy Report (Docket No. 25-IEPR-02)

In conjunction with the filing of its Electricity Resource Plan Transmission Form T-1 (Form T-1), the San Francisco Public Utilities Commission (SFPUC), a department of the City and County of San Francisco, respectfully submits this Repeated Application for Confidential Designation pursuant to Cal. Code Reg. section 2505(a)(4).

On March 18, 2025, the Energy Commission designated as confidential the information provided in SFPUC's 2025 Form T-1 pursuant to Cal. Code Reg. section 2505(b). SFPUC requests the same confidentiality designation for the information provided in this year's 2026 Form T-1, because the information is substantially similar to the information previously submitted in its 2025 Form T-1 (which was submitted on February 14, 2025). All facts and circumstances relevant to confidentiality remain unchanged from those in SFPUC's 2025 Application for Confidentiality. As explained in its 2025 Application, SFPUC relies on Government Code sections 7930.205 and 7922.000, and Evidence Code section 1060 as the basis for confidentiality of the information identified in this Repeated Application.
