Beginning November 25, 2025, HEEHRA rebate income verifications are open for **new single family heat pump HVAC projects. All HEEHRA projects must be installed and invoiced by December 31, 2025 to take advantage of 25C tax credit** that expires at the end of the year and is only available for heat pumps placed into service by December 31, 2025. This Energy Efficient Home Improvement Credit tax credit could provide additional financial benefits to homeowners. All HEEHRA projects must be completed and invoiced by February 28, 2026.

The HEEHRA Phase I program provides up to \$8,000 in single-family rebates to incomequalified, California homeowners for the installation of a new, energy efficient and program-qualified heat pump HVAC system. Homeowners with approved HEEHRA income verifications work with their TECH-certified and HEEHRA-trained contractor to submit a reservation request. To check the status of your income verification and/or pending HEEHRA rebate reservation, email TECH.info@energy-solution.com.

Projects must have an approved reservation to apply for HEEHRA rebates.

Projects installed before receiving an approved reservation are not eligible for HEEHRA rebates.

The HEEHRA Phase I program continues to process and finalize rebate applications of completed projects for both single-family homes and multifamily properties.
