On October 22, 2025, the National Lighting Contractors Association of America (NLCAA) submitted the final component of the 2025 update report required by Section 10-103.1(d)2 of the Building Energy Efficiency Standards (Energy Code) to the California Energy Commission (CEC). In accordance with Section 10-103.1(d)2, update reports shall be approved through the amendment process provided under Section 10-103.1(f). In its 2025 update report, NLCAA proposes non-substantive application amendments to meet 2025 Energy Code requirements in Section 10-103.1(c) for a nonresidential lighting controls acceptance test technician certification provider (ATTCP). Attachment 1 to this letter summarizes NLCAA's amendments.

On October 29, 2025, CEC staff completed its review of NLCAA's 2025 update report application amendments and determined they comply with the 2025 Energy Code.
