The California Community Choice Association¹ (CalCCA) submits this petition to request a time extension for comments due December 31, 2025, on the December 17, 2025, *IEPR Commissioner Workshop on Energy Demand Forecast Results*² (Workshop).

I. INTRODUCTION

The 2025 Integrated Energy Policy Report (IEPR) is unique in that it is being prepared at the leading edge of potential, but uncertain, changes in demand due to a host of factors. The potential for new large loads (*e.g.*, data centers) in particular are leading to significant uncertainty in the anticipated level of peak load and energy. At the same time, development of new resources is struggling to keep pace with needs even absent significant load growth due to a host of issues, including federal policy shifts, continued supply chain disruption, permitting, and increasing

competition worldwide for a limited amount of supply. Given that the IEPR establishes the basis for various procurement obligations at the California Public Utilities Commission, notably Resource Adequacy and new resource procurement to meet the Integrated Resource Plan, the implications of forecast accuracy are significant for both reliability and affordability.

Comments on the December 17, 2025, Workshop will be the final opportunity for parties to provide information to the California Energy Commission (Commission) on this important topic for the 2025 IEPR. CalCCA will work with its member community choice aggregators (CCAs) to formulate a fulsome response to the Demand Forecast Results. With the end-of-year holiday season, however, many of the CCA staff will be out of the office for much of the period between December 17, 2025, and December 31, 2025. Given the importance of these final comments, CalCCA requests that the comment deadline be extended to January 16, 2026. Doing so will allow parties to fully evaluate the Workshop and develop comments to inform the Commission's important decisions regarding the Demand Forecast Results.

II. CONCLUSION

For all the foregoing reasons, CalCCA respectfully requests the consideration of this request for an extension of time to January 16, 2026, to comment on the December 17, 2025, IEPR Commissioner Workshop on Energy Demand Forecast Results.
