To Whom it May Concern:

This Confidentiality Designation accompanies the resubmission of Demand Forms 1-7, which were originally submitted on June 16, 2025. The resubmission includes the addition of projected data for Forms 1.1b and 1.2 for the years 2025-2036. It does not add to or modify any other information in the Forms submitted June 16, 2025. The Confidentiality Designation associated with the June 16, 2025 submission is unchanged.

As a public agency, SMUD requests that the CEC designate the data identified below and included in SMUD's resubmission as confidential pursuant to the Title 20, section 2505(b) of the California Code of Regulations.

Section 2505(b) requires the CEC to designate information as confidential when the entity seeking confidentiality of that information is a federal, state, regional, or local agency that possesses information pertinent to the responsibilities of the CEC and has been designated by the applicant as confidential under the California Public Records Act or the Freedom of Information Act.
