Notice of CalSHAPE Program Updates on Grant Extensions, Expired Grants, and Amendments 20-RENEW-01

The California Energy Commission (CEC) is providing notice of changes to the California Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Program's treatment of ventilation grant extensions, expirations, and amendments. These changes are being made to ensure all grant requirements and payments will be completed by the upcoming program deadlines as the CalSHAPE Program comes to an end. Important program dates are below:

- June 1, 2026 – CalSHAPE Plumbing Program Final Reporting Deadline
- October 31, 2026 – CalSHAPE Ventilation Program Final Reporting Deadline
- December 1, 2026 – CalSHAPE Funding Liquidation. All Unspent Funds Returned to Utilities.
- January 1, 2027 – CalSHAPE Program Sunset

Please make every effort to submit complete and accurate final reporting before the grant end date to ensure all grant reporting can be approved and the grant fully paid by the CalSHAPE funding return date of December 1, 2026.

Ventilation Grant Time Extensions and Review Process

Effective immediately, the latest grant term end date for CalSHAPE Ventilation grants requesting extensions is June 1, 2026, rather than October 31, 2026. If the grant currently has an end date between June 2 and October 31, 2026, the end date will not be affected.

In addition, ventilation grant time extension requests will no longer be processed through the CalSHAPE system. LEAs requesting an extension must submit to CEC the request including a status update for each site included in the grant. CEC staff will review extensions, and approvals will be granted based on time needed to complete the project with a latest updated end date of June 1, 2026.

Ventilation Grant Reconciliation Report Submission

Effective January 1, 2026, Grantees will be able to submit the required Reconciliation Report at the same time as the Assessment Report. Submission of the Reconciliation Report will no longer be dependent on CEC approval of the Assessment Report.

Ventilation Grant Expiration

Grantees are required to submit both the Assessment Report and the Reconciliation Report by the grant term end date for ventilation grants.

For expired ventilation grants where the Assessment Report has been submitted to CEC on or before the grant term end date, but not the Reconciliation report, Grantees will be provided a 30-day grace period to submit the Reconciliation Report through the CalSHAPE Online System. This grace period expires February 13, 2026.

Ventilation Grant Amendments

Budget amendments will not be processed for any CalSHAPE grants.

CEC strongly recommends all Grantees submit their required reports and documentations by their grant end date or earlier, to assist with meeting all grant and program deadlines. If grantees need assistance with reporting submissions or corrections, or have any questions, please email CalSHAPE staff at calshape@energy.ca.gov.
