**4. Strain on Community Resources:** A fire at the proposed facility may heavily strain local emergency services, and may place unsustainable demands on local water resources. Additionally, costs may be passed to taxpayers for special equipment, emergency training, and post- fire environmental remediation.

**5. Lack of Local Control and Community Benefit:** Solano County has an active moratorium on battery energy storage projects while developing regulations. The project's use of the AB205's "Opt-In" program is intended to circumvent local control. Additionally, NextEra has entered into a PPA with an out of area energy provider, eliminating energy discounts for the local residents and only adding risks.

The CEC should deny the Corby Battery Energy Storage System Project permit, despite its proximity to the Vaca-Dixon Substation. This is due to significant public safety risks, adverse agricultural and environmental impacts on prime Solano County farmland, potential transportation disruption, a strain on community resources, negligible community benefits, and the developer's attempt to circumvent local government oversight. Prioritizing the health, safety, environment, and agricultural heritage of Solano County, along with respecting local and community voices, must outweigh any financial incentives or cost-saving measures for the developer.
