The California Energy Commission (CEC) will host a joint remote-access workshop with Pacific Gas & Electric Company (PG&E) and Southern California Gas Company (SoCalGas) to discuss proposed energy-related gas research initiatives for their respective Gas Research, Development, and Demonstration (Gas RD&D) Program plans.

The public can participate in the workshop consistent with the attendance instructions below. The workshop will begin promptly at the start time posted, and the end time is an estimate based on the proposed agenda. The workshop may end sooner or later than the posted end time.

**Agenda**

Staff from PG&E, SoCalGas, and the CEC will present proposed research initiatives organized around the themes of Gas System Integrity and Decarbonization. There will be an opportunity for public comment; input related to environmental and social justice priorities is particularly encouraged. Feedback from the workshop will support the Investor-Owned Utility (IOU) and CEC staff in developing their respective proposed Gas RD&D research plans, which will be submitted to the California Public Utilities Commission (CPUC) in June 2026.

**Background**

The CPUC designated PG&E, SoCalGas, and the CEC as administrators for the Gas RD&D Program, which is funded by surcharges from consumers who receive public utility gas corporation gas services to support public interest research and development. The IOUs and CEC each develop a proposed research plan for the Gas RD&D Program each year.

CEC invests about \$24 million annually in gas-related research to promote and establish a cutting-edge portfolio of research and development that will lay the groundwork for California's next phase of clean energy innovation and deployment.

The overall Gas RD&D Program invests strategically to deliver communitywide benefits, advance energy equity, and transition to a decarbonized future that supports California's most vulnerable communities.
