CEC Staff,

Acton is currently experiencing yet another brush fire on Friday, April 3rd 2026.

The Acton "Crown Fire" started off Soledad Canyon Road on A-2 land sometime after 10:30am, quickly spreading by Santa Ana winds in a west/southwesterly direction, threatening homes. The fire origination is approximately 3 miles southwest of the proposed PSRP site.

During a brush fire emergency, our residents mobilize *proactively* to offer assistance to neighbors in harms way.

There are truck and trailers being organized to help evacuate equine and livestock to safety.

Residents are offering corral and barn space.

These are residents helping fellow residents in need.

This is how our Acton community comes together in an emergency.

And this would not be possible during a BESS fire evacuation or shelter in place.

These residents trying to respond to help their fellow neighbors would not be allowed to enter the evacuation area to load and remove animals. Residents being evacuated would likely have to leave animals behind that they do not have trailer capacity to move to safety on their own.

This would be devastating for these residents who value their animals as family.

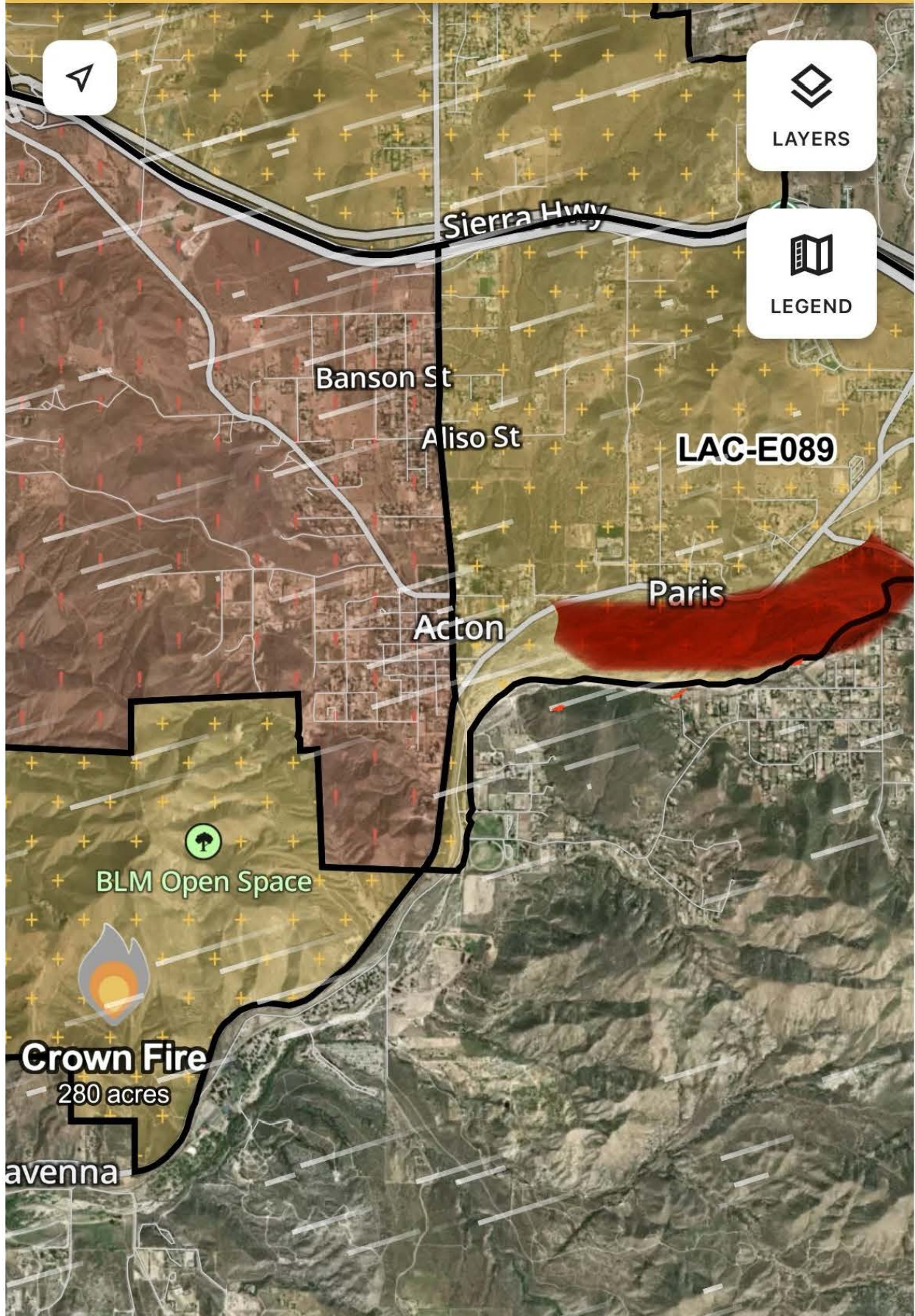
Please carefully consider this when evaluating the appropriateness of the site location for the Prairie Song BESS.

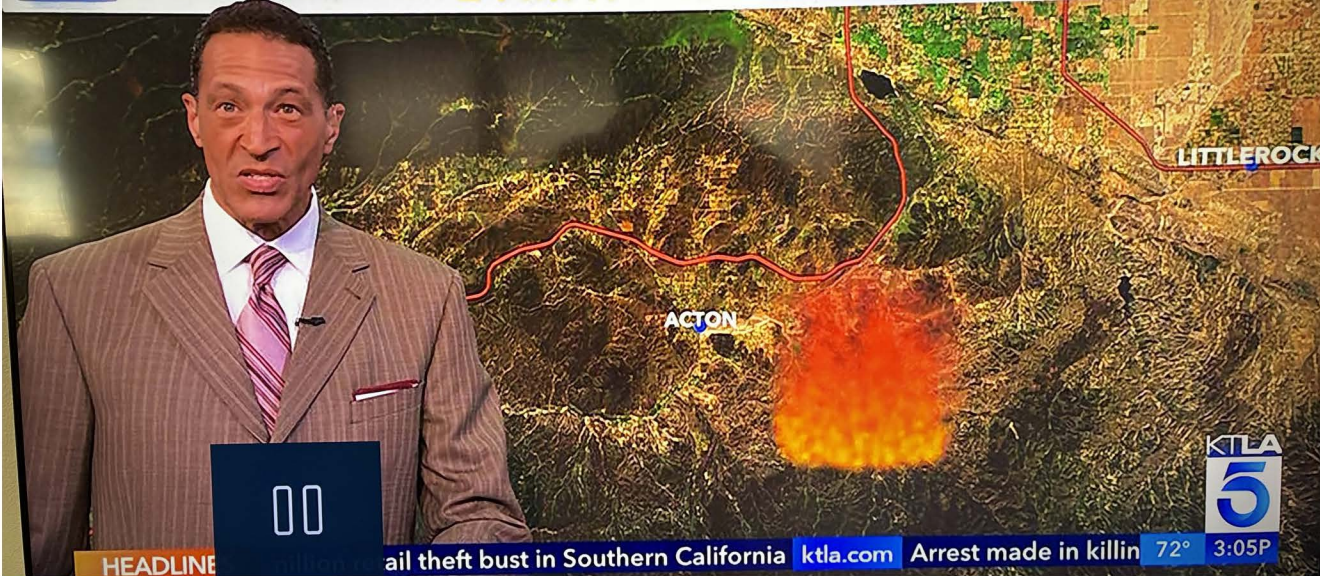
