Dear Mr. Bohan:

Pursuant to Sections 2501 *et seq.*, of Title 20 of the California Code of Regulations, Geysers Power Company, LLC (“GPC”), the project owner of the above-listed Commission certified projects, hereby submits this *Repeated Application for Confidential Designations* for the 2025 fire protection system (“FPS”) inspection, testing, and maintenance (“ITM”) reports, hereinafter “Repeated Application.” The 2025 ITM reports for the above-listed projects are submitted in compliance with Condition of Certification FIRE PROTECTION-3.<sup>1</sup>

By your letter dated February 2, 2022, “the public interest in ensuring that details regarding the status of fire protection systems and schedule for repairs and installation of systems at the Geysers facilities do not fall into the wrong hands outweighs the public interest in immediately knowing the system status or schedule for system repairs or installation.”<sup>2</sup> As such,

“the ITM records and summary of corrective actions setting forth the system status and schedule for system work will be subject to the same two-year confidentiality period from the date of the report.”<sup>3</sup>

This Repeated Application similarly seeks confidential designation for the ITM reports associated with FPS inspections conducted in 2025 for two years from the date of the reports. This Repeated Application is being submitted because the 2025 ITM reports contain information that is substantially similar to the previously submitted information that was granted confidential designation by your February 2, 2022 letter. All facts and circumstances relevant to the confidentiality designation remain unchanged.

Specifically, GPC requests confidential designation for the records listed in the table below. Consistent with prior FIRE PROTECTION-3 annual submissions, all documents in the foregoing table are being submitted to Commission staff via the Kiteworks secure file transfer system.
