Reminder Report Submission Deadline for CalSHAPE Ventilation Program

This is a reminder that all California Schools Health Air, Plumbing, and Efficiency (CalSHAPE) Ventilation (A&M and U&R) grantees must submit all required documentation, including final Reconciliation Reports, by their individual grant term end date or October 31, 2026 – whichever is earlier. The California Energy Commission (CEC) strongly recommends and encourages all Grantees submit required documentations prior to their grant term end date to allow sufficient time for review, possible corrections, and disbursement of funds.
