On behalf of GWF Energy LLC (“GWF”), pursuant to Title 20, California Code of Regulations, §1769(b), we submit this notification of an operator change for the GWF Tracy Combined Cycle Power Project, Hanford Energy Park Emergency Peaker Project and Henrietta Peaker Power Plant Project (collectively, “Projects”) in the above-referenced matters.

As described previously in a letter submitted to the California Energy Commission (“CEC”) on March 1, 2013, GWF was acquired by affiliates and co-investors of Highstar Capital. GWF will continue to be the legal owner and permit holder of the Projects. GWF will continue to be the party responsible for compliance with the CEC’s conditions of certification for the Projects. However, GWF is using Star West Generation Management Company, an affiliate of GWF, to provide operational services for the Projects.

Accordingly, the owner of the Projects will continue to be GWF Energy LLC, and the operator of the Projects will be Star West Generation Management Company.

I have been authorized to make this application and certification on behalf of the Applicant. With my signature to this letter, I certify under penalty of perjury that the information contained in this application for confidential designation is true, correct, and complete to the best of my knowledge.
