RSES online training programs--both ATEs and ATTs--continue to adhere to the 2022 Code Cycle through the end of 2025, and began the 2025 Code Cycle to prepare for 2026. ATEs and ATTs are signing up and renewing at a more regular pace now, and there has been a lot more interest in the program.

RSES migrated from the ESCO DocReg into the ComCerts registry in October of 2025. We update this on a consistent basis based on customer feedback and CEC requests.

RSES will continue to get the word out to CA contractors, technicians and facility managers on the importance of Title 24 certification and the process to achieve it.
