Hello Mr. Dobbs,

Please find below the response to your comment sent to docket # 12-BSTD-1.

As you noted, during the development process for the 2013 update to the California Green Building Standards Code, Part 11 of the California Building Code (also known as CALGreen), the California Air Resources Board and the California Energy Commission collaborated on refrigerant leak reduction measures for new supermarkets. The proposed language for the refrigerant leak reduction measures has been moved to the outdoor air quality section of CALGreen. This particular section of CALGreen is contained in the express terms for proposed building standards of the California Building Standards Commission. The express terms for proposed building standards of the California Building Standards Commission are located under the primary heading 'California Building Standards Commission (BSC)' and secondary heading 'BSC 07/12 - 2013 California Green Building Standards Code (CGBSC), Part 11'. The proposed language for the refrigerant leak detection measures may be found in Section 5.508 Outdoor Air Quality, beginning on page 16.
