Sycamore Cogeneration Company (SCC) has submitted a request to the California Energy Commission (CEC) to amend the Sycamore Cogeneration Project Design. In November 1989 Texaco formed a new subsidiary called Texaco Cogeneration and Power Company (TCAP) which is the umbrella company for all Texaco power projects including the Sycamore and Kern River (Omar Hill) cogeneration companies. TCAP is using office space at the Sycamore facility. To accommodate TCAP's increase in personnel SCC has identified the need for expansion of the existing parking lot at the Sycamore Administration Building in the Kern River Oil Field. The proposed expansion will be limited to the north side of the existing parking lot, will increase the existing parking lot by 19,000 square feet and will provide 45 new parking spaces.

STAFF RECOMMENDATION

Staff concludes that the proposed amendment is noncontroversial in nature, and recommends Commission approval for the following reasons:

- Staff analyzed the request and concludes there would be no significant additional environmental impacts associated with approving the request;
- Staff requested comments from all interested parties, and did not receive opposing comments from any interested party or agency;
- 3. The proposed change retains the intent of the Decision adopted by the Commission;
- 4. The proposed change is based on information which was not reasonably or readily available to the parties prior to Commission certification; and
- 5. The licensee, SCC, concurs with CEC staff's proposed new condition for the parking lot expansion.

CONCLUSION AND ORDER

The California Energy Commission hereby adopts Staff's recommendation and findings as its own, and Orders that the Sycamore Cogeneration Project Design be modified so the project facility is expanded by 19,000 square feet, adding 45 new parking spaces. Sycamore shall abide by the current Conditions of Certification in constructing the parking lot. Further, the California Energy Commission hereby adopts the following amendment condition for the Sycamore Project parking lot expansion:

 Construction activities will be confined to the designated parking lot expansion area. No additional area will be used for construction purposes such as equipment storage and parking, lay down areas, or new access roads. Any such activity will be confined to the designated construction area, existing roads, and well pads.

Verification: Upon completion of parking lot expansion, SCC will notify CEC staff that the site is ready for inspection.
