Hearing Officer Cochran,

On behalf of the High Desert Power Project (HDPP), we thank the Committee for the "Presiding Member's Proposed Decision Granting Interim Relief to Drought-Proof the Facility." We appreciate the additional water year granted for use of MRB Water Rights and believe that this relief will help ensure that HDPP is available to assist with electric reliability in Southern California in the wake of the Aliso Canyon storage issues. HDPP will provide comments and propose clarifying language to Condition of Certification SOIL&WATER-1 in advance of the May 17th Business Meeting.

On the question of interim relief on percolation of the SWP Water supplies that are now available, we note that while there seems to be general agreement among all parties as to the positive impacts related to percolation of SWP Water, the Presiding Member's Proposed Decision is silent on the issue of percolation.

We are writing to ask whether we can expect another order on percolation as interim relief. Specifically, will there be a second order issued prior to the May 17th Business Meeting addressing percolation?
