BIO:

Are you able to help obtain a copy of the Biological Opinion for the Colusa Generating Station from Rick Crowe?

TRAFFIC AND TRANSPORTATION

How many trucks would be needed for summer delivery of water including an extremely hot day?

Would the truck drivers be operational employees using rented trucks or would a water

delivery service provider be hired? [I think the Final Decision requires that employees be drawn from the local labor pool.]

I realize you are dealing with a lot of issues currently, but I am requesting a quick turnaround. If you can have this back to me by close of business today, that would be great, If you have it to me tomorrow or Tuesday at the latest (Monday is a holiday here), we can work with that too.

Thanks very much. If you have any questions for me, don't hesitate to contact me.

P.S. Subsequent to our internal meeting this morning to discuss the concern about groundwater and the need for a groundwater supply analysis, I do not have a request for any additional information. Our staff has reached agreement that this issue does not warrant any further consideration. We can discuss this further when we speak on the phone later today or tomorrow.
