ORDER REGARDING USE OF PRIOR ADVISORS AND NOTICE OF MARCH 21, 2017 COMMITTEE CONFERENCE

BACKGROUND

The High Desert Power Plant (HDPP) was certified by the Energy Commission on May 3, 2000, and began commercial operation in April 2003. The HDPP is an 830 megawatt (MW) natural-gas-fired, combined-cycle electric generating facility located in the City of Victorville in San Bernardino County that uses water for cooling purposes. The HDPP's use of water has the potential to affect a unique location where faulting has lifted the bedrock base of the groundwater system to land surface and forces groundwater to discharge to the Mojave River channel. This area, known as the Transition Zone, contains a mesquite bosque that serves as habitat for a variety of species.

In 2015, High Desert Power Project, LLC (Petitioner) filed a "Petition for Modification to Drought-Proof the High Desert Power Plant" (Petition). The Energy Commission assigned a Committee to conduct proceedings on the Petition. For a comprehensive review of the proceedings on the Petition, please see the "Committee Orders Regarding the Scope of Future Proceedings" filed July 12, 2016 (Scoping Order). Additional information on the HDPP, its water usage, and the current proceedings may also be found in the "Commission Adoption Order- Commission Decision Granting Interim Relief" (Interim Relief Decision).

On June 1, 2016, the Committee filed a memo outlining its consultation with certain staff experts and counsel (Linda Bond, Caryn Holmes, and Paul Kramer) (June 1 Memo).⁵ Following the initial HDPP certification proceeding and before the current Petition, Ms. Bond assisted the Energy Commission in the creation of the water model used for the

HDPP to account for water "banked" by the HDPP through injection. Ms. Holmes and Mr. Kramer served as counsel for Energy Commission staff (Staff) in prior proceedings. The June 1 Memo indicated that the Committee would disclose "any information upon which it bases a decision which is not otherwise in the record of this proceeding."

On August 11, 2016, the Committee held a status conference (August Status Conference). The notice of the August Status Conference stated its purpose was to discuss the issues raised by the Scoping Order and the Interim Relief Decision, and included specific questions to be addressed. During the August Status Conference, Petitioner raised concerns for the first time about information the Committee may have received from Ms. Bond, Ms. Holmes, and Mr. Kramer. Petitioner subsequently filed additional information regarding its position about the Committee's use of information that it had received from these individuals.

The Committee filed disclosures on November 21, 2016, that reported non-privileged communications between the Committee members and Ms. Bond, Ms. Holmes, and Mr. Kramer (the Disclosure). Excluded from the Disclosure is any legal advice that may have been received from Ms. Holmes or Mr. Kramer. The Disclosure provided the parties with 10 days to address them in writing; in specific, the Committee requested the parties to state in writing whether they waive the right to challenge the proceedings based on the disclosures made.⁸

Staff responded by waiving objections to the inclusion of the non-privileged communications in the record for these proceedings. Intervenor California Department of Fish and Wildlife did not file any response to the Disclosure.

On November 30, 2016, Petitioner filed its response in which it did not waive objections to use of the information contained in the Disclosure. Petitioner stated that it was reserving its rights, even though it did not have a present intent to advance these claims. Petitioner also stated that it believed the Committee needed to discontinue consulting with Ms. Bond, Ms. Holmes, and Mr. Kramer.¹⁰

On January 13, 2017, Petitioner filed additional comments on the Disclosure. This second filing offered suggestions for the further processing of the Petition. Petitioner stated that it had no objections to the Committee (as currently constituted) and the Hearing Officer, Susan Cochran, from continuing to process the Petition. However, Petitioner continued its assertion that Ms. Bond, Ms. Holmes, and Mr. Kramer be disqualified from further work with the Committee and the Hearing Officer. While Petitioner maintained its general objections to the information in the Disclosure, Petitioner stated that its concerns in this regard did not apply to the Hearing Officer or to the Committee and further stated its belief that the information in the Disclosure would

not affect the ability of the Committee or the Hearing Officer to hear the Petition in a fair, impartial and informed manner going forward. Petitioner also indicated that it would be filing a compromise proposal to bring the proceeding to an expeditious end.¹¹

ORDER

After reviewing the responses from Staff and Petitioner, the Committee agrees with Petitioner regarding the future conduct of proceedings in this case. The Committee and the Hearing Officer have had no communications with Ms. Bond other than those contained in the Disclosure. The Committee and the Hearing Officer have had no other privileged or non-privileged communications with Ms. Holmes or Mr. Kramer in this matter since the Disclosure. The Committee and the Hearing Officer will not consult with Ms. Bond, Ms. Holmes, and Mr. Kramer regarding the Petition in the future and will not rely on the information in the Disclosure from Ms. Bond, Ms. Holmes, or Mr. Kramer or on any undisclosed privileged communications from Ms. Holmes or Mr. Kramer in this proceeding.
