Purpose of the Committee Conference

ORDER REGARDING STATUS REPORTS

All parties are **ORDERED** to file a status report on or before May 26, 2017. The status report shall include:

1. A brief summary of the agreements, if any, that the parties may have reached at the Staff Workshop.
2. A summary of the subject areas that remain disputed and require adjudication, and the precise nature of the dispute for each issue.
3. Proposals for briefing deadlines, impact of scheduling conflicts, or other scheduling matters, including the amount of time required for any evidentiary hearing.

Notice of Closed Session Deliberations

At any time during the Committee Conference, the Committee may adjourn to a closed session in accordance with California Government Code section 11126, subdivision (c)(3), which allows a state body, including a delegated committee, to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.

Transcripts

Parties are responsible for identifying errors in the transcripts of the proceedings. Corrections to the transcripts must be filed within 30 days of the filing of a transcript.

Public Participation
