## **NOTICE OF CANCELLATION OF SEPTEMBER 20, 2017 EVIDENTIARY HEARING**

On August 25, 2017, the Energy Commission Committee<sup>1</sup> (Committee) assigned to conduct proceedings on the project owner's Petition for Modification to Drought-Proof the High Desert Power Plant (Petition)<sup>2</sup> provided notice of a Prehearing Conference and Evidentiary Hearing (Notice).<sup>3</sup> The Notice scheduled the Prehearing Conference on September 11, 2017, and the Evidentiary Hearing on September 20, 2017.

On September 1, 2017, the project owner, Energy Commission staff, and Intervenor California Department of Fish and Wildlife (CDFW) (collectively the Parties) filed a Comprehensive Stipulation and Agreement among the Parties (Stipulation).<sup>4</sup>

The Stipulation was discussed at the Prehearing Conference on September 11, 2017. The Parties have stated that the Stipulation resolves all issues presented by the Petition and that no Evidentiary Hearing is required. The Committee concurs.

NOTICE IS HEREBY GIVEN that the Evidentiary Hearing is cancelled.
