**COMMENTS:**

I received a phone contact today from Mr. Kerby E. Zozula, Engineering Division Manager at the VCAPDC. He expressed concern with the timing for VCAPCD actions on a Preliminary Determination of Compliance (PDOC) and Final Determination of Compliance (FDOC) indicated on Staff's Proposed Schedule contained in the CEC's August Issues Identification Report (tn: 205664) and included on a staff presentation at the August 27, 2015 Environmental Scoping Meeting and Informational Hearing. Mr. Zozula stated that the VCAPCD's local Rule 26.9 (New Source Review – Power Plants) allocates up to 180 days to make a decision on a PDOC, and up to 240 days to make a decision on a FDOC, from the date an application is accepted as complete. The application for Authority to Construct for the Puente Power Project was accepted by the VCAPCD on May 28, 2015, and Mr. Zozula they will require the full time allocated by Rule 26.9 to reach a decision on the PDOC and FDOC.
