### Agenda

At the October 13, 2015 workshop, the PMAC will hear presentations from industry stakeholders and may engage in post-presentation discussion. Topics will include:

- What were the drivers of the high gasoline prices in Southern California during the spring and summer of 2015?
- What activities and methods can potentially minimize disruptions to California fuel supplies?
  - How do different activities and methods compare in terms of effectiveness, implementation barriers, and cost?

## Background

The California Energy Commission established a Petroleum Market Advisory Committee to better understand factors and conditions related to petroleum price fluctuations, the impacts on consumers, and policy options that may affect markets.

The Committee consists of five petroleum fuels market experts appointed by the Energy Commission. These leading energy economists and experts will provide the Energy Commission and state regulators with independent advice and insights on issues affecting the market, from local policies to global events.
