**SERVICE OF COMPLAINT AND SCHEDULING ORDER**

On July 26, 2011, California Energy Commission Executive Director Robert P. Oglesby ("Complainant") filed a *Complaint Against DyoCore, Inc.* ("Complaint"), alleging that DyoCore violated the intent of the Emerging Renewables Program ("ERP"), and, in particular, Appendix 3, Section (A)(2) of the Emerging Renewables Program Final Guidebook ("ERP Guidebook"), by submitting grossly overstated information regarding the performance characteristics of the DyoCore SolAir wind turbine ("DyoCore turbine") in order to have the DyoCore turbine listed by the Commission as eligible for use under the ERP. Complainant requests that the DyoCore turbine be immediately removed from the Energy Commission's "List of Eligible Small Wind Turbines" on the ERP website, and that the Energy Commission provide guidance regarding the resolution of applications for rebate reservations and payment requests under the ERP for small wind systems that use DyoCore turbines, and take such action as may be necessary to recover ERP funds that were paid as rebates for such systems. In addition, Complainant requests that the Energy Commission refer this matter to the Attorney General for investigation and prosecution, as appropriate.

The Complaint is brought pursuant to Section 1231. Pursuant to the procedures set forth in Section 1231:

**Commission Response to the Complaint filed pursuant to Section 1231**

1. In accordance with Section 1232(a), the Energy Commission Chairman or committee assigned to this proceeding must take either of the following actions within 30 days after the Complaint was received by the Energy Commission Chief Counsel, which was July 26, 2011:
  - a. Dismiss the matter upon a determination of insufficiency or lack of merit of the pleadings (specifying whether the dismissal is with or without prejudice); or
  - b. Serve the Complaint upon DyoCore, Inc. and other persons identified in Section 1231(b)(7).

2. The Chief Counsel's Office is directed to immediately serve the Complaint on DyoCore, Inc. and other persons identified in Section 1231(b)(7).
3. Within twenty-one (21) days after service, DyoCore shall file and serve an Answer to all persons identified on the most current Proof of Service list on file with the Docket Unit.
4. Energy Commission Staff is directed to prepare a written assessment of the Complaint and the Answer. The staff assessment shall be filed and served by first class mail (or electronically if so indicated on the Proof of Service) on all persons identified on the most current Proof of Service on file with the Docket Unit within seven (7) days of service of the Answer.
5. The governing procedures for the resolution of the Complaint filed pursuant to Section 1231 shall be those codified at Sections 1200 through 1236.5 as attached, together with the informal hearing procedures in Article 10 of the Administrative Procedures Act (Government Code, §§ 11445.10 through 11445.60). Further procedures will be ordered as necessary by the committee assigned to this proceeding by subsequent order of the Commission, or if none has been assigned, the Chairman.

It is so **ORDERED**.


