Parties and the public may attend the meeting in person at the above location or by telephone and/or by computer via our "WebEx" web conferencing system. Background

The proposed P3 would replace two aging gas-fired steam-generating units (Units 1 and 2) at the existing Mandalay Generating Station (MGS), with a new General Electric (GE) Frame 7HA.01 natural gas-fired, combustion turbine generator (CTG) and associated auxiliaries. Construction laydown and parking areas would be within the existing MGS site. P3 would upgrade and repurpose the existing MGS maintenance and warehouse structures, transmission interconnections, and ancillary systems to the extent feasible. No offsite linear developments are proposed as part of the project. If P3 is approved

and developed, MGS Units 1 and 2 would be demolished following commissioning of the new generating equipment. Demolition of MGS Units 1 and 2 was added to the project in a “Project Enhancement and Refinement” document filed by the applicant on November 19, 2015³.

Purpose of the Committee Status Conference

The Committee will conduct the Status Conference to discuss the progress made in the proceeding, to provide feedback on the Preliminary Staff Assessment⁴, and to discuss any other matters relevant to the proceeding. It may also address any then-pending motions, petitions, or requests that are ready for consideration.

To ensure a productive status conference, the Committee invites all parties to file a status conference statement to the project docket by no later than Friday, September 23, 2016. The statements should identify the topics the parties would like to discuss with the Committee during the status conference.

As allowed by California Code of Regulations, title 20, section 1207, the Status Conference may be conducted by the Hearing Officer without either Commissioner being present.

Closed Session

At any time during the status conference, the Committee may adjourn to a closed session in accordance with California Government Code section 11126, subdivision (c)(3), which allows a state body, including a delegated committee, to hold a closed session to deliberate on a decision to be reached in a proceeding the state body was required by law to conduct.

Public Adviser and Public Participation

Members of the public are welcome to participate in the status conference. It is not necessary to be an intervenor to participate in the public process.
