Applicant hereby submits its Status Report No. 9 for the Puente Power Project (“P3”) per the Committee’s revised Scheduling Order issued on October 14, 2016. Following is a summary of key events that have transpired since the Committee Status Conference on September 27, 2016. Applicant is not aware of any impediment to adhering to the current schedule for the remainder of the proceedings.

FDOC Issued

On October 14, 2016, the Ventura County Air Pollution Control District (VCAPCD) issued the Final Determination of Compliance (FDOC), including responses to all comments received on the Preliminary Determination of Compliance (TN #214005-1 through #214005-15). The FDOC concludes that P3, as proposed, will comply with all applicable air quality laws, ordinances, regulations and standards.

Data Requests Related To Project Enhancements Issued And Responses Provided

Data requests related to the Refinement to Transmission Interconnection (TN #213002) and the Outfall Removal and Beach Restoration (TN #213802) were issued by CEC staff on October 11, 2016 (TN #213968) and by interveners City of Oxnard and Robert Sarvey on October 14, 2016 (TN #214004 and #215016, respectively). Applicant provided responses to the Sarvey data requests on October 31, 2016 (TN #214303), and to the CEC staff and City of Oxnard data

requests on November 1, 2016. As indicated in the responses to the CEC staff data requests, Applicant has also been in contact with the California Department of Fish and Wildlife, the Los Angeles Regional Water Quality Control Board and the United States Army Corp of Engineers regarding the Outfall Removal and Beach Restoration refinement.

FSA Workshop

Applicant supports holding a Final Staff Assessment (FSA) Workshop in the community to solicit input from the public on the FSA. Applicant recommends that the FSA Workshop be held the week of December 5, 2016.
