## **COMMITTEE ORDER GRANTING PETITION TO INTERVENE**

Upon consideration of the Petition to Intervene filed by Fighting for Informed Environmentally Responsible Clean Energy (FFIERCE) (Petitioner), the Committee designated to conduct proceedings in the Application for Certification for the Puente Power Project (P3) makes the following findings:

1. On November 4, 2016 a Petition to Intervene in the P3 proceeding was filed by:

2. The Petition was timely filed and contains the information required by California Code of Regulations, Title 20, section 1211.7;
3. No opposition to said Petition has been filed;
4. Intervention is granted at the Committee's discretion to the degree that it finds intervention reasonable and relevant. The Presiding Member or Committee may impose conditions on all intervenors' participation in the hearings in order to promote the orderly conduct of the proceeding; and
5. Petitioner's interests are relevant to the above-captioned proceeding.

**THEREFORE**, the Committee **ORDERS** that the Petition to Intervene in this matter be **GRANTED** for the Petitioner-requested subject areas of Public Health, Project Description, Project Alternatives, Compliance and Closure, Biological Resources, Soil and Water Resources, Greenhouse Gas Emissions, Air Quality, Worker Safety/Fire Protection, Hazardous Materials Management, Cultural Resources, and Socioeconomics and, to the extent that they impact public health and environmental justice, Facility Design, Efficiency, Reliability, Transmission Line Safety and Nuisance and Transmission System Engineering, and that Petitioner be placed upon the Proof of Service List as an intervenor. The Petitioner may make a motion to the Committee to participate in additional subject areas.

Petitioner may exercise the rights and shall fulfill the obligations of a party as set forth in all orders issued in this matter and California Code of Regulations, Title 20, section 1212. The deadlines for conducting discovery and other matters shall not be extended by the granting of this Petition. (Cal. Code Regs., tit. 20, § 1211.7(d).) The discovery period in this matter closed on March 7, 2016.

The Energy Commission welcomes and values intervenor participation in its energy facility siting process. A link to the California Code of Regulations, Title 20 describing intervenor participation is available on the right hand side menu of the Public Adviser's webpage at:

As an intervenor, Petitioner is required to file and serve documents on other parties and to follow the Energy Commission's procedures and orders regarding presenting witnesses and evidence. Petitioners are further required to review the *General Orders Regarding Electronic Document Formats, Electronic Filing and Service of Documents and Other Matters* (found at: <https://efiling.energy.ca.gov/getdocument.aspx?tn=205168>), rules regarding filings, the rules of evidence that apply at the evidentiary hearings, the rules prohibiting off-the-record contacts with Commissioners or the Hearing Officer about the merits of a project, and the rules about filing data requests. (Cal. Code Regs., tit. 20, §§ 1001 through 1216, and 1716.)
