subject: Revised Topic Spreadsheet

As I promised yesterday, attached is a revised version of the spreadsheet that we worked with at yesterday's Prehearing Conference. Rather than have you wait until tomorrow for an even more refined version (as to formatting, certainly), I'm getting it out to help you plan with your witnesses and to see if I made any errors in reordering the topics according.

I observe that Day 1 has become fuller than we may be able to handle. As the day progresses, we'll need to make some strategic decisions about pushing parts of some of the day's topics to the following day so that we can be sure to hear from those who can only be with us on Day 1.

For the later part of Day 3 we'll likely have to start Land Use before Mr. Street is available. If necessary, we'll pick up his portion during or after Biological Resources.
