Subject: Puente Power Project - Invitation to Participate in the June 5, 2017 Committee Conference

On behalf of the California Energy Commission's Puente Power Project Committee, I invite you or a representative of California ISO, to participate in the June 5, 2017 Committee Conference on the Puente Power Project.

On April 27, 2017, the City of Oxnard filed supplemental testimony in the Energy Commission's Puente Power Plant proceeding on the Moorpark sub-area needs.¹ On May 11, 2017, NRG Oxnard Energy Center, LLC responded to this filing with a motion to exclude that testimony.² On May 25, 2017, Energy Commission staff and Intervenor City of Oxnard filed in the docket transcriptions of the discussion held at the May 1, 2017, California ISO Board of Governors meeting regarding the Moorpark sub-area and the Puente Power Project proceeding.³ According to the transcript, you stated that you would speak with the Energy Commission on this matter.⁴

The agenda for this Committee Conference includes a discussion of the comments made at the May 1, 2017, California ISO Board of Governors meeting, as well as the above-mentioned motion. According to the Committee's current schedule, additional Evidentiary Hearings are scheduled to occur on July 26, 2017, with no other meetings scheduled between June 5 and July 26. The June 5 Committee Conference would be an excellent best opportunity for the California ISO to convey and discuss their thoughts with the Committee. We invite you to please send a representative to attend the Committee Conference, preferably in person, or by telephone if necessary.

The Committee Conference begins at 9:30 a.m. on June 5, in the Energy Commission's Art Rosenfeld Hearing Room. Please see the attached Committee Conference notice,⁵ which includes the meeting agenda.
