Dear Mr. Ali,

On behalf of Pacific Gas and Electric Company (PG&E) DayZen LLC hereby requests that the Petition For Amendment filed for the Colusa Generating Station (06-AFC-9C) on June 28, 2016 (Petition) be timely processed as described below. The original Petition requested approval of 1) addition of a Warehouse; 2) addition of electrical equipment and three electrical cabinets to allow gradual increase of load to the electric motors for each fan on the Air Cooled Condenser (ACC); and 3) installation of rotating intake screens to control algae blooms at the water intakes for the Tehama Colusa Canal (TCC).

CEC Staff issued a data request on September 8, 2016, to which PG&E promptly responded in September 13, 2016. One of the data requests pertained to obtaining cultural resources information from the Bureau of Reclamation concerning the installation of the rotating intake screens at the water intakes for the TCC. That information has been difficult to obtain promptly and therefore PG&E hereby requests the CEC Staff to split the Petition For Amendment into two actions. The first would be to approve the Warehouse and addition of the electrical equipment to allow variable loading of the ACC (Warehouse and ACC Variable Speed Petition). The second action would be approval of installation of the rotating intake screens at the water intakes for the TCC (Intake Screen Petition).

PG&E is submitting a separate check for \$5000 so that the Intake Screen Petition can be processed as a separate Petition. The sole purpose of this request is to allow Staff to quickly process the Warehouse and ACC Variable Speed Petition right away. The Intake Screen Petition can then be processed

after the information requested by Staff in its Data Requests can be obtained from the Bureau of Reclamation.

PG&E requests that the CEC publish the analysis for the Warehouse and ACC Variable Speed Petition as soon as possible. Thank you for your consideration and prompt attention to this matter.
